Organizational Setting and Reporting

This position is located in the Environment Office in the Office of Director Mission Support Division of the Africa Union-United Nations Hybrid Operation in Darfur (UNAMID), El Fasher. The incumbent will report to the Environment Officer.

Duties and responsibilities:

Within delegated authority, the Associate Environmental Engineer NOB is responsible for the following duties:

- Supports the implementation of the DFS Environmental Guidelines in the mission.
- Provides input for incorporation in the Mission's environmental budget.
- Provides input in the preparation of consolidated reports on environmental actions of all mission sites and identifies problem areas to be addressed by the relevant Sections within the mission.
- Reviews statements of work, contracts and services for the disposal of waste, in accordance with international and national environmental standards, and provides recommendations to the supervisor.
- Supports the coordination of all activities related to environmental compliance in the mission's military, police and civilian components.
- Assists with preparation of an Environmental Action Plan, guidance materials and instructions aimed at achieving environmental objectives.
- Participates in the assessment of environmental conditions through baseline studies and implements monitoring and evaluation procedures.
- Supports the implementation of the environmental emergency response plan in the Mission area.
- Assists with the development and implementation of environmental awareness and training activities aimed at building mission capacity to meet mission environmental objectives.

- Supports the development of environmental project proposal for implementation under quick impact projects (QIP).
- Collaborates and maintains liaison with other UN agencies, local authorities and Non-Governmental Organizations (NGOs) dealing with environment issues in the mission area.
- Keeps up to date on environmental developments.
- Performs other duties as assigned.
