18th meeting of the Tripartite Coordination Mechanism on UNAMID's mandate took place at the UN headquarters in New York. During the meeting, delegates from the African Union, United Nations and Government of Sudan welcomed progress made in the implementation of the Mission's mandate as well as the cooperation received from the host government.

Participants urged UNAMID, the UN Mission for Ebola Emergency Response, the UN Country Team and other relevant agencies to take necessary assistance in this regard.

South Darfur Women Discuss Implementation of UN **Security Council Resolution 1325**

n 29 September 2014, as part of global open days on UN Security Council Resolution 1325 (2000) on women, peace and security, UNAMID's Gender Advisory Section organized a one-day forum for women in Nyala, South Darfur to identify the priorities, concerns and needs of women in the area. The session brought together more than 60 women representatives from the Darfur Regional Authority, the South Darfur Legislative Council, traditional women leaders and members of the state committee on UNSCR 1325.

Addressing the women's forum, Ms. Yegerawork Angagaw, UNAMID's Senior Gender Adviser, explained that the session was an opportunity to assess the impact of the implementation of the landmark resolution 1325, the achievements so far, the challenges faced and the way forward.

The participating women were also encouraged to share their experiences, concerns and priorities as a contribution to national and regional efforts to resolve conflicts and peace building. The outcomes of these global open days are expected to inform and influence policies and programmes related to the implementation of Resolution 1325 as well as highlight challenges faced by women and their contributions to conflict resolution and peace building.

Ms. Angagaw reaffirmed the Mission's continued logistical and technical support to women's committees in Darfur in the implementation of the resolution.
